### 1. Website Visitors

Like most website operators, Polyxel collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Polyxel's purpose in collecting non-personally identifying information is to better understand how Polyxel's visitors use its website. #### 3. Advertisements

## 5. Polyxel uses Google AdWords for remarketing

Polyxel uses the remarketing services to advertise on third-party websites (including Google) to previous visitors to our site. ## 7. Cookies

To enrich and perfect your online experience, Polyxel uses "Cookies", similar technologies and services provided by others to display personalized content, appropriate advertising and store your preferences on your computer.

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Polyxel uses cookies to help Polyxel identify and track visitors, their usage of http://polyxel.com, and their website access preferences.
